

“Privacy Policy

World Wildlife Sanctuaries (“WWS”) is committed to respecting the privacy of your personal information. This notice relating to this SPAR Sail 4 Wildlife Website Privacy Policy explains our policy for dealing with personal information that we collect through this Website.

In our Privacy Policy, we refer to your “personal information” which means information that identifies you as an individual or from which your identity may be reasonably ascertained. Your address and phone number are examples of personal information.

We will post any changes to our Privacy Policy on the Website, so we encourage you to check this notice relating to our Privacy Policy from time to time.

Information Collected

The information that we may collect about you through this Website includes:

- the content of electronic forms you submit via this Website which includes personal information when you apply to be selected and registered as a join as a Volunteer, make a donation, apply to participate in an event, purchase any products or services or which you send to WWS for any other reason; and
- any messages or comments you submit to us via this Website; and
- any information you may provide to us during a telephone or other conversation or via any other written communication.

We may not be able to provide you with the full range of products or service through this Website or to assist you to fully participate in a WWS Campaign or Event or as a Volunteer if we are not provided with the information outlined above.

In common with many websites, we may collect information that tells us about visitors to this Website. For example, we may collect information about the date, time and duration of visits and which pages of this Website are most commonly accessed. This information is generally not linked to the identity of visitors, except where this Website is accessed via links in emails which refer to the possibility that click-throughs to links may be traced.

We aim to provide you with information and invitations that we consider may be of interest or relevance to you in respect to anything proposed or undertaken by WWS, its sponsors or third parties.
